# **INDOOR WATER USE**

TCWD estimates approximately seventy-five gallons is the average indoor water use per person per day. Of course, this number can vary from person-to-person, and day-to-day. This information can be instrumental when considering your household's monthly water usage, and different ways to conserve personal consumption. Consider the following consumption estimates:

 A single flush of a toilet in a home that was built in the late 1980s or early 1990s, and still has the original toilets: 3.5 gallons per flush 2 TCWD'S ON TAP

- Brushing your teeth for 2 minutes without turning off the water: *3 gallons*
- A 10 minute shower (with no flow restrictor in the shower head): 25 gallons
- A single load of laundry in a 5 year old washing machine: 42 gallons
- A leak in your home plumbing can account for one-sixth of all indoor water use. At the estimated value of 75 gallons per person per day, this amount can be up to 12 gallons

#### **OUTDOOR WATER USE**

Customers and communities can be environmentally proactive, and save money at the same time, by using water more efficiently in outdoor applications. The following water efficient lawn watering practices can help maintain a beautiful yard and conserve valuable water supplies.

### **GENERAL CONSERVATION PRACTICES**

- Adjust sprinklers to water only grass areas and not impervious surfaces such as streets, driveways and walkways.
- Use sprinklers that spray low large drops vs. high fine ones.
- Use hand held soakers for small trees, shrubs and plants.
- Use shut off nozzles on hoses and repair leaky hoses and fittings.

#### **WHEN TO WATER**

- Don't use a fixed schedule for lawn watering.
   Apply water only when it is needed. Over watering can promote diseases and affect the health of the lawn
- A simple test for determining if grass needs water is to walk on the lawn and if you leave foot prints, it may be time to water the lawn.
- A good soaking once or twice a week is better than watering every day. Allowing the soil to dry between watering will allow the roots to grow to greater depths and help make turf more drought tolerant.

# **BEST TIMES FOR LAWN WATERING**

 Water during the cool part of the day to minimize water lost to evaporation. Early morning hours are the best preferably (4 a.m. to 6 a.m.) or later in the evening (between 8 p.m. and 10 p.m.). Watering during TCWD's peak water demand period (6 p.m. to 9 p.m.) should be avoided.
